3. CHAIRMAN'S ANNOUNCEMENTS

Solent Marine and Maritime Steering Group (SMMSG)

The Chairman announced that Councillor Donna Jones has stood down as the Committee's representative to the Solent Marine and Maritime Steering Group (SMMSG) and that Councillor Stephen Philpott has been appointed as replacement.

Solent Recreation Mitigation Partnership – Bird Aware

The Chairman reminded members that invitations had been circulated for a visit on either the 14th or 16th November to The Titchfield Haven Nature Reserve and asked that if members hadn't responded, they were invited to do so.

Fixed Link Tunnel

The Chairman advised the Committee that a group on the Isle of Wight have been discussing the possibility of a fixed linked tunnel between the Isle of Wight and Fareham. The Chairman felt the Committee would find it beneficial to have more knowledge of this and advised that the Joint Committee will receive a presentation in this respect at the December meeting.

8. Integrated Water Management Study
