**1. APOLOGIES FOR ABSENCE AND CHANGES TO THE OVERVIEW AND SCRUTINY COMMITTEE MEMBERSHIP**

**2. MINUTES**

RESOLVED that the Minutes of the meeting of the PfSH Overview and Scrutiny Committee held on the 13 January 2021, be signed and confirmed as a correct record.

**3. CHAIRMAN'S ANNOUNCEMENTS**

**5. DEPUTATIONS**

**6. PFSH MANAGERS REPORT**

The Overview and Scrutiny Committee received a report from the PfSH Coordinator, Paddy May, on items of PfSH business which are significant but do not justify a full report, which will be brought to the Joint Committee for decision. Paddy May advised the Committee that further information in respect of the recent announcements on the Levelling Up Fund and the Community Renewal Fund, the DEFRA Land Management System pilot and the joint work to align activities with Solent Transport and the Solent Leaders' Forum was available and that this will be included within the report to be considered by the Joint Committee under Part B.

**7. PFSH BUDGET MONITORING REPORT 2020/21 AND PROPOSED BUDGET 2021/22**

## 8. GREENPRINT FOR SOUTH HAMPSHIRE

The Overview and Scrutiny Committee received a verbal update from Alison Barnes, Chief Executive from the New Forest National Park Authority and Simon Eden from the Southern Policy Centre. The update outlined details of the Joint Committee report requesting funding to resource work on the framework being developed to progress the Greenprint for South Hampshire work.

The Overview and Scrutiny Committee expressed their support for the development of a Greenprint for South Hampshire and asked if more could be done to raise public awareness as there is currently no source to refer people to when questions are asked about the initiative. The Committee asked that it be recommended to the Joint Committee to consider that this be a priority to produce an accessible public guide promote the Greenprint for South Hampshire.

RESOLVED that the Overview & Scrutiny Committee: -

  - i. AGREE funding to resource the development of a framework for the Greenprint for South Hampshire; and

**9. STATEMENT OF COMMON GROUND - FINDINGS OF THE ECONOMIC EMPLOYMENT AND COMMERCIAL NEEDS (INCLUDING LOGISTICS) STUDY**

The Overview and Scrutiny Committee considered a report by Mike Allgrove, PfSH Consultant, which set out the findings of the Economic, Employment and Commercial Needs (including logistics) Study.

RESOLVED that the Overview & Scrutiny Committee: -

**10. PFSH NUTRIENT NEUTRALITY UPDATE**

The Overview and Scrutiny Committee considered a report by David Bibby Principal Planning Officer (Strategy), Test Valley Borough Council and Simon Kennedy, Strategic Environmental Planning Officer Partnership for South Hampshire. The report updated the Committee on progress towards the implementation of mitigation strategies that unlock the backlog of required housing consents caused by the requirement that all new housing be nutrient neutral.

Members commented, as they have done at previous Committee meetings, on the continued delays in progress and lack of support from Central Government to help mitigate the Nitrate issues. Particularly the affect that the delays in house building is having on PfSH authorities being able to meet their Housing Delivery Targets.

A motion was put forward by the Chairman – To ask PfSH to investigate moving this issue forward and seek Government support.

Having been duly proposed and seconded the motion was carried unanimously.

RESOLVED that the Overview & Scrutiny Committee:-

- a) NOTES the contents of this report;
- b) NOTES that Joint Committee will be asked to note the content of the report outlining PfSH's activity towards unlocking the delivery of housing which has been on hold due to the nutrient neutrality issue; and
- c) REQUESTS that the Joint Committee ask PfSH to investigate moving the nitrate issue forward and seek Government support.
