## **1. ELECTION OF CHAIRMAN**

Having been duly proposed and seconded, it was RESOLVED that Councillor Seán Woodward from Fareham BC be elected as Chairman for the 2023/24 municipal year.

## **3. APOLOGIES FOR ABSENCE AND CHANGES IN JOINT COMMITTEE MEMBERSHIP**

Andy Wannell was introduced to the Committee as the newly appointed Chief Executive for Fareham BC, replacing Peter Grimwood.

## **9. PFSH STATEMENT OF COMMON GROUND UPDATES AND REVISIONS**

This item was deferred until a future meeting of the Joint Committee.

## **10. PFSH MANAGERS REPORT**

The Joint Committee received the PfSH Co-ordinator's report from Paddy May, which provided an opportunity for issues which are significant, but do not justify a full report in their own right, to be brought to the attention of the Joint Committee for decision or for information.

RESOLVED that the Joint Committee NOTES the matters for information outlined in part B of the report.

## **11. PFSH STATEMENT OF ACCOUNTS**

The Joint Committee received a report from Johnathan Evans, Southampton CC which summarises the outturn against the budget for the financial year 2022/23 and Statement of Accounts 2022/23 for approval. The report also updates the revenue budgets for 2023/24 based on the outturn position and approvals at the previous Joint Committee meeting in April 2023.

RESOLVED that the Joint Committee:-

- a) NOTES the outturn for the financial year 2022/23 (Table 2);
- b) APPROVES the Statement of Accounts for the 2022/23 financial year and the Annual Governance Statement (Appendix 1); and
- c) NOTES the revenue budget for 2023/24 as set out in the report (Table 4).

## **12. SOLENT WADERS AND BRENT GOOSE STRATEGY**

The Joint Committee received a report from Deborah Whitfield Senior Nature-Based Solutions Manager, Hampshire and Isle of Wildlife Trust which provided an update on the progress of the elements of the Solent Waders and Brent Goose Strategy funded by the PfSH local planning authorities.

RESOLVED that the Joint Committee NOTES the contents of this report.

### 13. LOCAL NUTRIENT MITIGATION FUND

The Joint Committee received a report from Simon Kennedy, PfSH Strategic Environmental Planning Manager which sets out the proposed use of potential funding for the purposes of nutrient mitigation.

Members of the Committee discussed various areas across the region that would benefit from the proposed projects and asked that these be divided across the PfSH region. A question was raised about the proposed projects in the Winchester area, asking if these are within the PfSH boundary. Simon Kennedy advised that the phosphate issue impacting the Winchester area needs addressing as they have an immediate problem effecting their catchments.

Alison Barnes from the New Forest NPA requested that priority be given to the west of the region as there are areas in desperate need of water quality improvement measures. The Chairman addressed the Committee to explain that careful consideration will be given to prioritising projects moving forward, should the funding be provided, but also highlighted to the Committee that any improvement the water quality around the Solent will have a positive impact on the Solent as a whole.

RESOLVED that the Joint Committee:-

- a) NOTES the content of this report;
- b) AGREES the outline approach for use of the Local Nutrient Mitigation Fund should funding become available;
- c) APPROVES implementation of the following projects on receipt of funding
  - i. Water efficiency project,
  - ii. Small wastewater treatment works and septic tank upgrade project; and
- d) AGREES that a further report come back to the Joint Committee about the proposed governance needed for delivery of any project not listed in Recommendation c).

At the end of the meeting the Chairman addressed the Committee to make a special announcement – David Williams from Portsmouth CC will be retiring in September. On behalf of the Committee the Chairman thanked David for his support of the years and for all that he has done as the PfSH Chief Executive for PfSH. James Strachan from Eastleigh BC will be replacing David as the Lead Chief Executive. In response David Williams addressed the Committee asking that PfSH Members keep collaborating on creative and innovative projects and stressed the importance of working together to strengthen the partnership for the future.
